Quotations are requested from reputable Service Providers for the supply, delivery and installation of the branding of Cacadu Development Agency within the Cacadu District Municipal offices, 1<sup>st</sup> floor.

The Cacadu Development Agency (CDA) is a new entity that requires a unique identity that will create a lasting impression. The CDA is a municipal entity of the Cacadu District Municipality and covers the exact same District area as the municipality. The Cacadu District Municipality has developed an identity based on factors within the District area and as the CDA covers the same area, the branding should consider the similar factors accordingly.

The CDA requires the following as part of its branding:

- Logo design and identity refinement
- Application of Logo to letterhead
- Business cards, email signature
- Power-point Template
- 4 x Pull-up Banners
- Building signage (1 x Sticker on window 2.5m x 1.8m; 1 x Signage Board 1m x 1.47m)
